#### **1. RENTAL CONDITIONS**

Customer agrees to use all equipment solely for its intended purpose and in accordance with safety guidelines provided by the Company. All equipment remains the property of Patriot Party Rentals. Customer shall not move, modify, or sublease any equipment without prior written permission.

#### **2. DELIVERY, SETUP & PICKUP**

Customer agrees to allow sufficient access and clear space for timely delivery, setup, and removal. Delays or obstructions that prevent safe equipment setup may incur additional charges or cancellation of service.

#### **3. CARE & MAINTENANCE**

Customer is responsible for maintaining all rental equipment in good condition throughout the rental period. Equipment must not be exposed to unauthorized use, vandalism, excessive moisture, or misuse. Any lost, stolen, or damaged items will be billed at full replacement value.

#### **4. WEATHER POLICY**

Customer understands that certain weather conditions (including but not limited to high winds, rain, or extreme heat) may make equipment unsafe. Patriot Party Rentals reserves the right to cancel or halt usage

#### **5. DAMAGE OR LOSS**

Customer accepts full financial responsibility for any damage or loss (including theft) occurring during the rental period. Equipment not returned or excessively soiled may result in additional fees.

#### **6. RELEASE & WAIVER OF LIABILITY**

To the fullest extent permitted by Nevada law, Customer releases and discharges Patriot Party Rentals from any and all liability for personal injury, death, or property damage related to the rental or use of equipment, whether due to negligence or otherwise.

#### **7. INDEMNIFICATION**

Customer agrees to defend and indemnify Patriot Party Rentals against all claims, costs, or expenses arising out of the use of rental equipment by the Customer or any third party.

#### **8. GOVERNING LAW**

This Agreement is governed by the laws of the State of Nevada. Any dispute shall be brought in Clark County, Nevada.

#### **9. SEVERABILITY**

If any portion of this Agreement is found invalid, the remainder shall continue in effect.
